#### **Payment Terms**

#### **Owners:**

The full amount of Maintenance Fees & Real Estate Taxes are due by December 31<sup>st</sup>, 2023. The Special Assessment is due by March 01, 2024. In order to use your unit or bank your unit with an exchange company, you must pay the entire balance of fees invoiced. If you do not pay your fees in a timely manner, you will lose your ability to use your week at Telemark or bank your week with an exchange company.

**Past Due Accounts:** Past due accounts will be charged interest at 10% per annum. Finance charges on past due 2024 Maintenance Fees & Real Estate Taxes will begin on January 1, 2024. Finance charges on past due 2024 Special Assessment will begin on March 2, 2024.

### **Ownership Advantages - Options for 2024**

**Bonus Week**: *Christiana Villa* owners may reserve an additional week of the same size and color beginning 1/1/2024, for only \$350 for each week owned if you pay your fees in full by 12/31/2023. Similarly, *Telemark Pointe* owners may reserve an additional week of the same size and color for \$650 for each week owned. In both cases, the bonus week is only for use at Telemark, and it is not available for banking.

**14-day Vacation Packages:** Within 14 days of check-in, you may reserve an available unit for a maximum of 3 nights for \$180, or 4-7 nights for \$300, plus tax. This is a great way to spend more time at Telemark Condominiums for those who are more spontaneous in their vacation planning.

**Surplus Weeks:** For extra trading value, you can buy extra weeks from TIOA for \$99, plus tax. These are based on availability, and can ONLY be banked with RCI. These will be available for purchase after July 15<sup>th</sup>. RCI offers a program where you can "bundle" your credits/weeks for a price to extend the life of all your credits/weeks. Call Owner Services with questions or to purchase these weeks (one week per owner per week).
